National Prescription Drug Take-Back Day April 29, 2017 10:00 AM to 2:00 PM

Drug overdoses are killing more people than ever before even though Americans are becoming increasingly aware of the problems from prescription drug abuse. A recent public health study found that more than half of individuals who are prescribed an opioid pain medication never finish the prescription. Another U.S. government report shows that more than 70 percent of people who first misuse prescription drugs get them from their friends, relatives or simply take them without asking. Attacking the problem of prescription drug abuse takes a multi-faceted effort. Here is what **you** can do to help.

The Drug Enforcement Administration (DEA) has announced that the 13th National Prescription Take-Back Day will be Saturday, April 29, 2017 from 10:00 AM to 2:00 PM. The Take-Back Day provides a safe, convenient, and responsible means to prescription drug disposal, while also educating the public about the potential for abuse of medications.

The DEA began hosting the National Prescription Drug Take-Back Day in 2010. Since then 6.3 million pounds of medications have been collected for safe disposal.

It is important to get rid of old and unused medicines as soon as they are no longer needed. Some medications can become dangerous or ineffective over time. Other medicines can be abused by someone searching through your medicine stock.

On the National Prescription Take-Back Day communities will be sponsoring take back sites. <u>There are</u> <u>also pharmacies that will take medications all year round</u>. Call **1-800-222-1222** and poison center nurses will be able to answer your questions and help you quickly locate the nearest take-back site.
